1. This offer is open to legal residents of Canada making purchases in participating stores in Canada. The offer is not transferable and is valid only for the individual who purchased four (4) new qualifying Cooper® tires in a single transaction for personal household use. Void where restricted or prohibited by law.
2. Properly submitted and verified claims will be provided with the rebate (as described below) in Canadian dollars in the form of a Cooper Tires Visa® Prepaid Card (“Card”). The rebate will be emailed to you from notification@prepaiddigitalsolutions.com with instructions for choosing a physical or virtual Card. A valid and legible email address is required to receive the rebate. Lack of an email address will result in a physical Card being automatically selected and sent to the mailing address provided on the claim form. Access to your rebate expires 3 months from the date it is issued. You must select your Card within this time frame.
